### **PHARMACY**

- Successfully defeated requests for TRO and preliminary injunction at trial level and court of appeals in challenge to pharmacy benefit manager's business model that attempted to expand scope of who was considered to be ERISA beneficiaries.
- Represented a PBM in a dispute with a client regarding the alleged wrongful processing and payment of certain compound prescription drugs in federal court in Maryland. After negotiating an agreement to limit discovery, and prior to filing dispositive motions, the parties reached a favorable settlement.
- Appealed CMS' denial of hundreds of thousands of dollars in specialty drug claims before administrative law judge in order to obtain payment for specialty pharmacy.
- Defended award of multibillion-dollar state pharmacy benefit contract against protest filed by incumbent pharmacy benefit manager, residing in awarding state.

### **HEALTHCARE**

- Developed initial legal strategy and prepared initial summary judgment briefing on novel preemption argument that prevailed at trial-court level and was ultimately affirmed by U.S. Supreme Court.
- Obtained voluntary dismissal of nationwide consumer fraud class action involving air ambulance services following removal to federal court and filing of early summary judgment motion.

- Secured victory in the U.S. Court of Appeals for the Seventh Circuit on behalf of Group Health Cooperative of South Central Wisconsin in a matter originally filed as a class action in the U.S. District Court for the Western District of Wisconsin involving allegations of violations of the federal and Wisconsin Mental Health Parity and Addiction Equity Act and the Employee Retirement Income Security Act (ERISA).

## **FINANCE**

- Obtained summary judgment for financial institution on RICO and professional negligence claims brought by more than 70 people who claimed institution was complicit in Ponzi scheme in which plaintiffs asserted losses of more than \$44 million.
- Second-chaired trial defending Fortune 100 company in lawsuit involving breach-of-contract and tortious interference claims.

## **EDUCATION**

- Defended private-sector college against consumer fraud claims in five-week trial in Clay County, Missouri. Plaintiffs, five former students of the client's school, sought more than \$10 million in damages and \$3 million in attorneys' fees. After less than one day of deliberation, jury returned complete defense verdict on claims of four plaintiffs and awarded fifth plaintiff damages of less than \$8,000. Result was affirmed on appeal.
- Obtained summary judgment in Oklahoma federal court on all individual and class action claims against private-sector college brought by students who claimed they did not receive education they were allegedly promised.
