### OVERVIEW

if necessary. Glennon's class action experience includes state and federal proceedings involving advertising, bad faith, billing practices, contract interpretation, marketing, securities, unjust enrichment, and warranty claims, as well as defending numerous lawsuits filed under the Telephone Consumer Protection Act (TCPA), the Missouri Merchandising Practices Act (MMPA) and other state unfair and deceptive trade practice statutes.

**Commercial Contracting & Distributor Termination** | Following his longstanding representation of various clients in commercial disputes, Glennon's practice has evolved to also include those clients' commercial agreements—all with the benefit of seeing many of those contract terms tested in litigation. As a result, he leads a client service team of transactional attorneys that handles commercial agreements for a global technology company and has negotiated a wide variety of agreements including master, distribution, reseller, technology, service, supply, and other agreements—including agreements involving highly sophisticated "adverse" transaction parties, such as Amazon, Apple, Arcelor, Avnet, BNSF, Cisco, John Deere, Nokia, Norfolk Southern, Samsung, Sikorsky, and Union Pacific, among others. His experience ranges from complex long-term master agreements to clients' day-to-day terms and conditions, all with the benefit of a knowledge of the gap-filling provisions of the Uniform Commercial Code (UCC). He also advises clients regarding the termination of distributors and distribution agreements, providing advice to clients on distribution, franchise, and sale representative statutes in all 50 states.

**Commercial Litigation** | Glennon represents a variety of financial services, manufacturing, and technology companies in commercial disputes, including claims or lawsuits adverse to leading companies such as Alcatel-Lucent, Avnet, Boston Scientific, CalAmp, Carrier, Caterpillar, Cisco, Ericsson, Ford Motor Company, Huawei, Qualcomm, Sanmina, Siemens, Sierra Wireless, and Stryker. In such disputes Glennon works closely with in-house counsel and commercial leads, and sometimes does so "behind the scenes" so as not to unnecessarily escalate a dispute or to otherwise preserve the underlying supply chain or other commercial relationship. Most commonly, these disputes involve breach of contract, breach of warranty, indemnity, level of service or performance claims.

**Construction & Design** | Glennon's construction experience involves a variety of commercial, industrial, and municipal projects, including one of the country's largest mass transit systems, the nation's largest cement plant, power plants, and fiber-optic cable relocation. This work includes bond, breach of contract, default, defective workmanship, delay, engineering and design defect,

mechanics' liens, and supply/procurement claims. Even when the result is a favorable ruling, construction litigation can be particularly disruptive, expensive, and time consuming. As a result, where appropriate, Glennon often works with clients and the other project representatives to achieve a business or quasi-legal resolution short of litigation.

**Financial and Consumer Fraud Litigation** | Before returning to private practice Glennon was Unit Chief of the Consumer Protection Division of the Missouri Attorney General's St. Louis office, where he directed the investigation and prosecution of advertising, antitrust, consumer, marketing, and unfair practice claims, including a variety of multistate investigations coordinated by the National Association of Attorneys General (NAAG) and in joint state/federal investigations with representatives of the Federal Trade Commission (FTC). Since returning to private practice, he has continued to review companies' advertising and marketing practices for compliance with state and/or federal consumer protection statutes. He has also assisted clients with FTC and Attorney General civil investigative demands and related investigations, as well as numerous civil lawsuits asserting unfair and deceptive trade practice claims, including the Missouri Merchandising Practices Act. He has addressed a broad array of issues, including advertising review, automobile leasing, counterfeit goods, electronic commerce, health & safety, lending, promotions, and truth-in-lending (TILA) claims. He has handled numerous TCPA and Fair Credit Reporting Act (FCRA) cases.

**Intellectual Property & Trade Secret Litigation** | Glennon works with client product development and technical leads to address intellectual property and trade secret disputes and litigation. His experience in this area includes a wide range of products and technologies, including patented biotechnology, connectivity and other IoT components, counterfeit and gray-market goods, remote control systems, seed, thermal interface materials, transmitters, and wireless modules. While he often assists clients in resolving such disputes prior to litigation, he is counsel of record in over fifteen reported patent infringement decisions.

**Product Liability** | Glennon's product experience includes a variety of products and technologies, including appliances, biotechnology, boilers, control valves, cryogenic products, electrical equipment, emission controls, fiber-optic cables, ladders, lighting equipment and fixtures, plastic injection molding equipment, manufactured housing, motors, power tools, process control systems, pump systems, remote control systems, scaffolds, signal integrity products, transmitters, valves, and water heaters. The applications of such products and technologies include agricultural, business, commercial, construction, consumer, and industrial sectors.

This work often involves industry and consensus standards promulgated by the American National Standards Institute (ANSI), American Society for Testing and Materials (ASTM), CSA, the National Fire Protection Association (NFPA), Underwriters Laboratories (UL), and many others. Through this work he has significant experience with investigations and lawsuits relating to fires, explosions, and fatalities.

**Product Safety** | Glennon frequently works with in-house counsel, product safety officers, in-house engineers, and outside consultants when clients are addressing product defect, epidemic failure, and field failure claims, including business-to-business recalls and other corrective actions (i.e., industrial, commercial and non-consumer products), consumer product recalls and other corrective actions (i.e., Consumer Product Safety Commission (CSPC)), and safety investigations. This work includes reviews of ANSI, ASTM, CSA, CSPC, Occupational Safety and Health Administration (OSHA), NFPA, Department of Defense (DoD), UL, and other requirements.

**Telephone Consumer Protection Act (TCPA)** | Because of the uncapped liability associated with TCPA claims, as well as the provisions regarding “statutory” damages which require no proof of actual damages, class actions alleging violations of the TCPA routinely expose companies to judgments into seven, eight, or nine figures. These lawsuits can arise in a number of contexts, including artificial voice, facsimile, fax, recorded call, MMS, SMS, and text communications. Glennon and a team of colleagues at Husch Blackwell regularly review SMS and other text communications for compliance with the TCPA. Glennon has advised over two dozen clients regarding TCPA claims and/or compliance.

**Advertising & Marketing** | Glennon’s experience includes numerous advertising reviews and false advertising claims during his tenure as Unit Chief with the Missouri Attorney General’s Consumer Protection Division, as well as reviewing client advertising and marketing documents following his return to private practice. These advertising reviews distinguish puffery from advertising claims, document claim substantiation, and address comparative advertising concerns. Since returning to private practice, in addition to advertising reviews, he has handled numerous false advertising and unlawful merchandising practices claims, including private class actions as well as matters involving the FTC, FTC guides or regulations, or the Missouri Attorney General.
