OVERVIEW

For CGL policies, Angela counsels insurance company clients regarding coverage for claims and litigates coverage disputes on the side of the insurance company.

Together with Children’s Hospital of Wisconsin, she also co-leads a pro bono guardianship clinic that helps provide equal access to the often-convoluted guardianship process.
