Farmobile LLC

Farmobile secured a complete defense victory in enterprise-threatening trade secret litigation.

Featured Experience

Husch Blackwell Team Gains Favorable Judgment for Client in Trade Secret Litigation

Farmobile, an independent farm data company, faced allegations that it misappropriated trade secrets from competitor Farmers Edge. The lawsuit sought a judgment declaring the plaintiff to be the owner of certain Farmobile intellectual property. Persuasive argument by the Husch Blackwell team, led by Marnie Jensen and including Kamron Hasan, resulted in a complete victory on summary judgment for Farmobile. When the decision was affirmed in the Eighth Circuit, the appellate court's decision noted unprotected information shared with a third party by plaintiff, and that our clients were not hired as inventors or under relevant contractual obligation.

 competing valuation for Streck, Inc, in shareholder oppression case, one of Nebraska's
 largest valuation disputes. Decision was affirmed on appeal before the Nebraska Supreme
