FEDERAL APPELLATE EXPERIENCE

- Briefed, orally argued, and won appeal in *A.L.M. Holding Co. v. Zydex Indus. Private Ltd.*, --- F.4th ---- (Fed. Cir. 2026), securing a precedential opinion that clarifies Article III standing requirements in patent infringement lawsuits.
- Briefed and orally argued, before a panel and en banc, *Gilbank v. Wood Cnty. Dep't of Hum. Servs.*, 111 F.4th 754 (7th Cir. 2024) (en banc), successfully convincing a majority of the court to adopt a new standard for evaluating federal subject-matter jurisdiction under the *Rooker-Feldman* doctrine.
- Briefed, orally argued, and won appeal in *Louis DeGidio Inc. v. Industrial Combustion, LLC*, 66 F.4th 707 (8th Cir. 2023), on behalf of manufacturer of institutional boilers and burners in commercial dispute with former distributor. The Court affirmed summary judgment, cementing a complete defense victory on claims for violation of the Minnesota Franchise Act, breach of contract, and promissory estoppel.

- Won appeal in *Stockbridge Munsee Community v. Ho-Chunk Nation*, 922 F.3d 818 (7th Cir. 2019), a case brought by one American Indian tribe against another over the latter's right to conduct gaming under the Indian Gaming Regulatory Act. Affirming the district court's ruling in favor of the Ho-Chunk Nation, the Court held that the plaintiff-tribe's claim was both outside the statutory zone of interests and barred by the statute of limitations.
- Briefed and orally argued appeal in Federal Circuit on behalf of steel nails distributor seeking reversal of Department of Commerce determination regarding applicable duties, in case involving complex questions of administrative law and procedure.
- Represented provider of micromobility devices in D.C. Circuit in case challenging denial of permit applications as unconstitutional, arbitrary, and capricious, and otherwise in violation of administrative-law rules.
- Authored successful amicus brief in *Guam v. United States*, 141 S. Ct. 1608 (2021), a case providing important guidance on the interpretation of the Comprehensive Environmental Response, Compensation and Liability Act (CERCLA, or Superfund). Filed on behalf of a politically and geographically diverse coalition of 26 states and territories in support of the prevailing party (Guam), the brief was discussed in detail at oral argument.
- Authored several briefs in the U.S. Supreme Court, including cert petitions, briefs in opposition, and amicus curiae briefs at the merits stage, at the petition stage, and in support of emergency applications.
- Briefed appeals as lead or co-lead appellate counsel in the U.S. Courts of Appeals for the D.C., Sixth, Seventh, Eighth, Ninth, Tenth, and Federal Circuits.
- Presented oral argument several times in the U.S. Courts of Appeals for the Sixth, Seventh, Eighth, and Federal Circuits—including an en banc oral argument in the Seventh Circuit.
