# **Cell Site Developer, Verizon Win Permit for New Wireless Communications Tower**

Central States Tower III LLC, a builder and manager of cell towers, turned to Husch Blackwell after the planning commission for Eau Claire, Wisconsin, rejected its application for a conditional use permit because a cell tower already stood on the site. Our team challenged the commission's determination, arguing that its decision violated state law, and worked with the client's carrier partner, Verizon, to remove the existing Sprint (now T-Mobile) tower. The ensuing settlement benefited all parties by allowing construction of a tower that can accommodate multiple carriers to serve the immediate community while minimizing the number of towers in the vicinity.
