- Served as lead counsel on two significant appeals before the Texas Third Court of Appeals involving judicial review challenges to the Public Utility Commission decisions that granted Lone Star's applications and authorized it to provide transmission service in ERCOT. These cases required extensive appellate briefing, oral argument preparation, and deep knowledge of Texas administrative and utility law. The court rejected these challenges, ruling in the Commission's and Lone Star's favor.
