Emily is passionate about her areas of practice and frequently speaks at national and state conferences on current trends impacting post-acute care and behavioral health.

Experience

- Successfully appealed on behalf of physician group in the Midwest that had been issued an overpayment determination substantially in excess of \$150,000, effectively reducing the overpayment to just over \$1,000.
- Successfully appealed multiple hospice audit cases, including cases before the Office of Medicare Hearings and Appeals and state Medicaid cases. Emily's current success rate before ALJs with the Office of Medicare Hearings and Appeals in hospice audit cases is over 80%.
- Successfully appealed extrapolated overpayments imposed against youth behavioral health providers totaling over \$1.2 million, reducing the overpayments to just under \$7,000.
- Emily has successfully appealed physician Medicare enrollment effective dates, ensuring services provided during earlier dates were covered by Medicare.
- Successfully appealed the state's calculation of hospital outlier payments, securing additional payments of over \$2.5 million for a children's hospital.
- Successfully represented a client against a Medicare reimbursement audit by the OIG, which initially alleged improper payments of over \$140 million (later reduced to a \$50 million demand). Through a comprehensive appeal process including expert testimony on statistical sampling and hospice care determinations, the Husch Blackwell team achieved a remarkable victory when an administrative law judge overturned nearly all claim denials, reducing the extrapolated overpayment to less than \$10.
