Recall Demand Withdrawn for Self-Balancing Scooters

The Consumer Product Safety Commission (CPSC) initiated an industrywide investigation that led to a safety recall of nearly 300,000 self-balancing (hoverboard) scooters. Brandan's team represented an importer/seller of hoverboards in months of negotiations with CPSC over the product recall. The team continued to advocate for the client, including obtaining testing and source information from the overseas manufacturer. The team's efforts demonstrated the safety of the hoverboards, and the client was one of the few companies in the United States not required to recall its products.
