# Political strategy added to regulatory efforts, resolving \$2 million payment delay for healthcare client.

Our healthcare client was denied access to approximately \$2 million of Medicaid reimbursement payments in Texas following the delayed approval of a change of control. Our initial legal team collaborated with Mark as a government relations advocate at Husch Blackwell Strategies in order to remedy the problem.
