A Quick Victory

When a Chinese manufacturer's booth was raided by U.S. Marshals at the largest consumer electronics show in the country, Steve's legal team leapt into action. They quickly learned that a competitor had secretly won a temporary restraining order against the Chinese manufacturer, claiming patent infringement in an effort to keep their products out of the U.S. market. Steve's team fought the preliminary injunction and accompanying lawsuit so thoroughly that the plaintiff withdrew their complaint within a month and chose not to pursue the case any
