Jennifer's extensive experience also includes arguing appeals before the Federal Circuit, navigating inter partes review (IPR) proceedings before the Patent Trial and Appeal Board (PTAB), and managing oppositions and cancellations before the Trademark Trial and Appeal Board (TTAB). Known for her strategic thinking and courtroom presence, Jennifer thrives in high-pressure environments and is committed to delivering results for clients, whether they are industry leaders or emerging disruptors.

## Experience

- Won ITC trial for complainant related to biotechnological invention.
- Won ITC trial for respondent resulting in findings of non-infringement, unenforceability and lack of domestic industry,
- Successfully represented several Fortune 100 companies as patent infringement plaintiffs.
- Secured summary judgment for one of nation's largest nonprofit hospitals in trademark infringement suit in federal court.
- Defended international gaming client in copyright infringement lawsuit against competitor in U.S. District Court, District of New Jersey.

- Won multimillion-dollar jury verdict of patent infringement for trace detection equipment in U.S. District Court, Eastern District of Virginia.
- Invalidated landscaping patent for global manufacturer after jury trial in U.S. District Court, Eastern District of Missouri.
- Earned a high-profile victory for wireless company before the Patent Trial and Appeal Board (PTAB), knocking out all disputed patent claims (175 in total) across eight related IPR petitions. The Board also reversed its previous stance on several patentability issues at stake in the IPRs, instead finding in the Final Written Decisions that the full record supported the client's arguments.
- Defended bank in a trademark dispute in the United States District Court of Colorado and sought naming rights in front of the Colorado Banking Board. Handled a preliminary injunction hearing and several hearings in front of the Colorado Banking Board. Resulted in a negotiated resolution.
- Prevailed before the U.S. Court of Appeals for the Federal Circuit on behalf of Sotera Wireless as it successfully invalidated eight of a competitor's patents in final, non-appealable judgments. Husch Blackwell had previously knocked out all disputed patent claims—175 in total—across eight related inter partes review (IPR) petitions before the Patent Trial and Appeal Board (PTAB) of the United States Patent and Trademark Office, resulting in a precedential PTAB decision that provides a strategy for petitioners to avoid discretionary denial of IPR under the *Fintiv* factors. (Not all decisions by PTAB are marked precedential, but the Board found Husch Blackwell's arguments and methods so useful that it marked this decision precedential to help future IPR parties in navigating PTAB procedure. - Representing group of companies defending patent infringement claims relating to safety circuitry, USB technology, and battery management systems for lithium-ion battery packs in portable power supplies. Case ongoing before the United States International Trade Commission.

## Experience

- Achieved major victory at the U.S. International Trade Commission, with the panel affirming a decision of the presiding administrative law judge (ALJ), which found that client ADC Solutions Auto, LLC (d/b/a Type S) did not violate Section 337 of the Tariff Act in relation to imported portable battery jump starters.
- Won ITC case for respondent with finding of non-infringement.
- Prevailed at the U.S. Court of Appeals for the Federal Circuit on behalf of Kansas-based client Ventria Bioscience (d/b/a InVitria and ExpressTec), when a three-judge panel affirmed a U.S. International Trade Commission's 2022 decision that found Wuhan Healthgen Biotechnology Corp. and its distributors in violation of U.S. trade law. The Federal Circuit affirmed both the finding of infringement and Ventria's satisfaction of the ITC's "domestic industry" requirement.
