### Commonwealth of the Northern Mariana Islands

Husch Blackwell put together a coalition to help clarify CERCLA in an influential U.S. Supreme Court amicus brief.

### Experience

- Second-chaired federal jury trial for Fortune 500 company involving contract and tort claims.
- Co-authored successful amicus brief before the U.S. Supreme Court in *Guam v. United States*, 141 S. Ct. 1608 (2021), a case providing important guidance on the interpretation of the Comprehensive Environmental Response, Compensation and Liability Act (CERCLA, or Superfund). Filed on behalf of politically and geographically diverse coalition of 26 states and territories in support of the prevailing party (Guam), the brief was discussed in detail at oral argument.
- Successfully challenged and defeated, before local zoning board, county's attempt to stop nonmetallic mining company from engaging in mining operations on property.
- Obtained jury verdict in favor of residential landlord in eviction action, where tenant sought compensatory damages, punitive damages and attorney's fees for alleged violations of Wisconsin Deceptive Trade Practices Act.
- Represented the Wisconsin Legislature before the Wisconsin Supreme Court in case regarding legislation's impact on regulatory authority of state-level administrative agencies.
