## OVERVIEW

**A trial attorney who has first chaired more than 50 trials, Rick defends clients in complex toxic tort litigation and catastrophic personal injury cases.**

Rick primarily represents private companies—often those with a Fortune 500 ranking—in high-exposure toxic tort cases, including exposures allegedly resulting in death. He routinely handles complex multi-plaintiff and class action cases, and he has tried cases at bench and jury trials across the country, appearing in courthouses in more than 20 states. Rick's litigation practice focuses on defending industrial and institutional cleaning, sanitation, and hygiene matters, including programs relating to water management and infection prevention.

His practice also includes representation of clients in fire and explosion cases. These cases have included electrical fires on cruise ships, fires in industrial and commercial buildings, and refinery explosions. He has extensive experience defending outdoor power equipment manufacturers. In addition, Rick represents insurers in toxic tort cases, and he has decades of experience defending mold and legionella litigation matters. He has handled mold exposure cases involving commercial real estate properties, educational institutions, multifamily housing, and military housing. He has served as national counsel for construction product manufacturers and a major military housing provider. Rick is also knowledgeable about benzene exposure matters, and he previously oversaw the benzene litigation program for a major multinational conglomerate. In addition, Rick regularly represents clients in general commercial litigation matters and other business disputes.

Acknowledged by his opponents as “one of the best cross-examiners” in practice, Rick regards litigation simply as storytelling. He knows that winning a case is a matter of first presenting a compelling narrative that relies on clearly-explained facts and science—along with performing the research necessary to discredit the opposition. Rick also understands the importance of humanizing both the client and the legal team: he calls on corporate witnesses who remind jurors of their friends and neighbors, and he assembles a diverse team so that juries hear the defense’s case from multiple perspectives.

Rick’s experience goes beyond the corporate world: a veteran and former active-duty JAG officer, Rick first cut his teeth in court as a prosecutor for the Army. He also served as an assistant U.S. attorney, prosecuting federal cases in Minnesota.

Known for his 100% commitment to his cases, Rick prioritizes client communication and ensures that clients have all the information necessary to make strategic decisions. Clients can have confidence that he is determined to achieve the best result possible whether through settlement, at trial, or on appeal.
