OVERVIEW

Baylee represents healthcare clients in regulatory compliance matters and litigation. She practices from Atlanta via our Link virtual office.

Baylee works with hospitals, health systems, and physician practices on both regulatory compliance and litigation matters. She advises on a wide range of healthcare regulations and related issues, including the Stark Law, Anti-Kickback Statute, False Claims Act, Eliminating Kickbacks in Recovery Act (EKRA), Georgia Certificate of Need requirements, Health Insurance Portability and Accountability Act (HIPAA) and state privacy laws, corporate practice of medicine questions, Medicare and Medicaid billing, and insurance regulations.
